PATH representatives made a presentation to the WBIA concerning their activities within the BID area.

LAPD SLO Pete Abaskharon also made a presentation to the Board about his efforts to assist in resolving homeless issues. Tremendous success has been realized within the District through his efforts with the Venice Four Square Church. Board Member Payne was generous in her expression of appreciation for the headway that has been produced through LAPD's work and that of the Church Pastors.

After discussion, Motion Lemmon; 2nd Payne: "The WBIA Board of Directors hereby approves a \$1,000 payment to Venice Four Square Church to defer costs associated with their efforts within the WBIA BID area." Unanimously approved.

Gilbert Perez, Clean Street Supervisor, provided an overview of Streetscape program activities conducted in the BID area. He answered questions and engaged in extended discussion with the Board on that topic.
